- select appropriate textile materials, working resources and product making methods;
- construct basic garment patterns;
- make garments and other textile products;
- repair and conduct basic maintenance of textile products;
- understand and use different professional literature, terminology and ICT;

Optional:

- select appropriate materials, construct patterns and make children garments;
- select appropriate materials, construct patterns and make sport garments;
- select basic and support materials, patterns and make female outer garments;
- select basic and support materials, patterns and make male outer garments;
- identify impurities and stains, carry put adequate washing, chemical cleaning and textile ironing procedures.

In addition, the holder of the certificate also upgraded his/her key professional skills and competences with key general knowledge and skills in line with national standards.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO HOLDER OF THE CERTIFICATE

The holder of the certificate can find employment at:

- garments industry;
