- maintain, repair, make and process frames, vehicle body and superstructure;
- diagnose the state of painted surfaces;
- prepare paint for application;
- maintain, repair and make interior and exterior painted or varnished surfaces;
- maintain and repair ventilation and heating appliances;
- maintain, repair and replace exhaust systems;
- fit auxiliaries and accessories in vehicles;
- maintain and repair rims;
- maintain, repair and provide antirust protection;
- advise clients about vehicle repair and maintenance works;
- master teamwork and cooperate well with co-workers, experts, clients;
- communicate with co-workers, experts, clients and use the appropriate professional terminology;
- use energy, materials, work resources and time rationally, economically and carefully in order to protect the environment;
- prepare a safe work environment, protect one's own health and the health of others.

In addition, the holder of the certificate also upgraded his/her key professional skills and competences with key general knowledge and skills in line with national standards.

The holder of the certificate can find employment at:

- vehicle body or panel beating shops;
