- think aesthetically and creatively as well as match colours;
- conduct work requiring manual skills;
- provide fashion consulting to clients and communicate successfully;
- select and coordinate all textile materials, means of work and ways of making products;
- design and fashion clothing cuts;
- make fashion clothing and collections;
- repair and undertake basic maintenance of textile products;
- understand and employ different professional literature, terminology and ICT;
- develop entrepreneurial mentality and promote one's products and services in the market.

In addition, the holder of the certificate also upgraded his/her key professional skills and competences with key general knowledge and skills in line with national standards.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO HOLDER OF THE CERTIFICATE

The holder of the certificate can find employment at fashion studios, craft workshops, trade centres by providing fashion consulting, ready-to-wear and textile industry, clothing repair shops, laundries and dry cleaner's, as a self-employed person and at other posts requiring knowledge and skills of textiles.
