3. ACQUIRED KNOWLEDGE, SKILLS AND PROFESSIONAL COMPETENCES

The holder of the certificate is qualified to:

- employ computer software for design, preparation and archiving of basic documents and documentation in line with requisite instructions;
- perform basic maintenance works of electrical and communication installations;
- set up and check the functioning of operation systems and peripheral devices;
- set up, test and update standard software in line with instructions;
- archive and protect databases;

Optional:

- monitor functioning, perform up-to-date maintenance of computer components and peripheral devices, remedy minor errors and organise the rectification of serious errors from external contractors;
- manage AV, projection and videoconference appliances;
- record, code and save sound, image and video in digital format;
- manage and conduct control by way of programmable devices;
- plane and elaborate simple programmes;
- use well-known solutions for new cases;
- connect computer systems into local networks and world-wide web, create user accounts and assign user rights;
- provide safety of local computer networks.

In addition, the holder of the certificate also upgraded his/her key professional skills and competences with key general knowledge and skills in line with national standards.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO HOLDER OF THE CERTIFICATE

The holder of the certificate can find employment at:

- set up and maintenance of standard software;
- production, assembly, repair, maintenance and sales of computer components;
- management of AV devices and control with programmable devices (applicants opting for the hardware module);
- set up and maintenance of network services as well as advising users on software use (applicants opting for the software module).


