3. ACQUIRED KNOWLEDGE, SKILLS AND PROFESSIONAL COMPETENCES

The holder of the certificate is qualified to:

- use technical documentation to perform carpentry work and transfer dimensions and heights from the plan to the facility;
- handle wood processing tools and machines;
- make basic woodworking joints and use fasteners;
- construct scaffolding, supporting frames, non-supporting and supporting constructions and roof trusses;
- install insulation material and implement roof works;
- choose and use wood protection and impregnating agents;
- rationally use material, energy and time;
- comply with health, safety at work and environmental protection principles;
- implement maintenance and rehabilitation work on wooden constructions;

Optional:

- correctly install hydro-insulation, thermal and sound insulation and use appropriate materials;
- handle light construction machinery for implementing less demanding demolition work, transport and construction work on construction sites and at construction facilities;
- install reinforcement in simple constructions and prepare and use mixtures for concrete and reinforced concrete;
- mplement roof works on simple slopes using various types of roof cladding;
- assemble and disassemble various types of prefabricated scaffolding and maintain the component parts of prefabricated scaffolding.

In addition, the holder of the certificate also upgraded his/her key professional skills and competences with key general knowledge and skills in line with national standards.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO HOLDER OF THE CERTIFICATE

The holder of the certificate can find employment at companies and crafts dealing with wood cutting and processing and the manufacture and installation of roof constructions and other construction elements. Employment is also possible in companies and crafts dealing with the construction of facilities and buildings. Self-employment is also possible.
