3. ACQUIRED KNOWLEDGE, SKILLS AND PROFESSIONAL COMPETENCES

The holder of the certificate is qualified to:

- use technical documentation to perform bricklaying work and transfer dimensions and heights from the plan to the facility;
- build walls of various thickness using bricks, modular blocks and stone employing typical brick joints;
- build pillars, stairs, chimneys, arches and cornices using different materials;
- apply interior and exterior plasters by hand or with a machine;
- set up and manufacture simple conventional panels and install reinforcement within panels;
- prepare concrete mixtures and use for supporting and non-supporting concrete and reinforced concrete constructions;
- install thermal, sound, hydro and fire protection insulation;
- pave surfaces with brick, concrete and stone elements;
- rationally use material, energy and time;
- comply with health, safety at work and environmental protection principles;
- implement construction work in installations and bricklaying works in the refurbishment of facilities;

Optional:

- implement earthworks with construction machinery and tools and perform basic maintenance;
- correctly install hydro-insulation, thermal and sound insulation and use appropriate materials;
- perform basic stonemasonry activities by hand;
- handle light construction machinery for implementing less demanding demolition work, transport and construction work on construction sites and at construction facilities;
- process, install and protect elements and make simple wooden constructions with conventional woodworking joints;
- prepare surfaces and material and perform ceramic tiling on simple interior and exterior surfaces and grout tiled surfaces;
- perform transport by forklift;
- implement roof works on simple slopes using various types of roof cladding;
- assemble and disassemble various types of prefabricated scaffolding and maintain the component parts of prefabricated scaffolding.

In addition, the holder of the certificate also upgraded his/her key professional skills and competences with key general knowledge and skills in line with national standards.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO HOLDER OF THE CERTIFICATE

The holder of the certificate can find employment at companies and crafts dealing with the construction of facilities and buildings and renovation work. Self-employment is also possible.


